I am registered with the Information Commissioners Office (ICO):

In line with UK General Data Protection Regulations, and as a professional registered with the Information Commissioner's Office, under the law of Consent (Article 6 of the General Data Protection Regulations (GDPR)), I am obliged as the Data Controller to share the following information regarding how your data is protected.

PLEASE HAVE YOUR PARENT/CARER TO READ THROUGH THIS WITH YOU

It tells you all about how I will make sure I keep all your personal information safely, and the rules that I follow to ensure it's done properly.

1. What information do I hold?

As a counsellor in private practice, I may collect the following information: Name, address, phone number, email address, date of birth, occupation, GP details, family relationships, previous experience of counselling/mental health support, current and past risks, details of your issues and any other information relevant to the service.

2. What I do with your information

<u>Contact Details:</u> Your contact details will be used to contact you for our work, including contacting you about appointments. They will not be used for any purpose other than those stated in the contract.

Storage: The information you give me is stored digitally on password protected devices. I do not hold paper records. Each client is allocated a Unique Reference Number (URN). I keep notes of our meetings on password protected devices; the notes will be securely deleted after the 6 years I am legally required to hold them for. Any texts, emails or other messages will be deleted after they have been read and any action taken, unless they form part of your notes. Yours and/or your parents/carers telephone number will be kept on my mobile phone and deleted when your contract is completed.

<u>Sharing Information:</u> Your information may be shared with: my clinical supervisor, a 'therapeutic executor' who would contact you in the event of my death or being unable to work and unable to contact you myself, your GP, and those who I am legally obliged to disclose your information to (as discussed in the Counselling Agreement). I will never share your data with anyone else unless you ask me to, or unless made to by law. In this event, I will try to inform you and your parents/carers whenever possible.









3. If you have been referred from another organisation

I will comply with this other organisation's policies as well as my own. Any excess information they may give me will be deleted once they have reimbursed me for the sessions we have had.

4. You have a right to see the information I hold

You have the right to ask for a copy of your personal information, I am legally bound to give you a copy free of charge within one month of your request. You also have the right to ask me to amend or change any incorrect information about you. This applies only to you, and not your parents/carers, as you are considered competent to consent to counselling in your own right in accordance with the Gillick Competence Test.

You have the right to ask for any information that I hold about you to be erased. This includes your personal information that is no longer relevant to original purposes, or if you wish to withdraw consent. In all cases and when considering such requests, these rights are obligatory unless it is information that I have a legal obligation to retain. You also have the right to receive the personal information which you previously provided and the right to transfer that information to another party.

If there are any aspects of this information that you do not wish to consent to, please let me know.

Consent can be withdrawn at any point. You have the right to see any information that I hold, you have the right to ask me to change any information that you deem incorrect and you can request for any information to be deleted (subject to legal requirements).
